MESSAGE FROM THE INDIANAPOLIS DEPARTMENT OF PUBLIC WORKS

There are many policies you should know as home owners. According to the DPW, property owner responsibilities include:

- Working with neighbors to clear brush, debris and other blockages from neighborhood creeks and ditches
- Maintain swales (a low or hollow place especially a marshy depression between ridges) and ditches, including roadside ditches, by mowing grass to eight inches or less, and keep them free of debris. Be sure not to mow when the ground is wet to avoid rutting
- Keep storm inlet grates, driveway culverts and cross pipes in good repair and clear of debris, trash, and leaves
- Not dumping debris/yard waste in or along waterways
- Picking up after pets to avoid pet waste from entering waterways
- Use approved practices for erosion control for creeks that run through private property. To endure the specific type of practice is permissible in waterways, be sure to check with the Department of Business and Neighborhood Services at (317) 327-8700
- AND always call CITIZENS ENERGY GROUP (CEG), at (317) 924-3311 (and press *2), to report flooding on city streets and side walks or illegal dumping in waterways

NEW RESIDENTS



NEIGHBORS LOOKING OUT FOR NEIGHBORS

We are living in times where it is more important than ever to get to know who your neighbors are. You never know



when you might need them in an emergency, etc. We need to be able to call upon a neighbor when the time arises. Please take the first step, and introduce yourselves to one another. If we all stick together, we can become our own "crime watch" group. We need to keep our eyes open to any suspicious activity around the area that we each live in. Always look over your shoulder, and if you see or hear something that looks to be "not normal," please contact the non-emergency sheriff immediately at (317) 327-3811. You might stop an act of crime by doing this one thing, not only for yourself and your family, but also for your fellow neighbor(s). We all need to be aware of our

surroundings at all times.

Many of our residents have formed small phone trees within their street(s), and communicate with one another when any abnormal behavior occurs. If you are interested in learning how to compile or organize such a phone tree, please call one of our HVHA board members and we will gather the information from one of the groups in our neighborhood. Please be diligent.

DID YOU KNOW?

It is a violation of the city ordinance to discharge water from sumps, pools and other sources onto the city streets and/or sidewalks? From the ordinance, "Such waste of water flowing from abutting premises upon or under a public way is hereby declared to be a nuisance and a violation of this Code."

HAZARDOUS HOUSEHOLD WASTE AND TOXIC DROP-OFF LOCATIONS

Hazardous household waste consists of items like cleaners, paint, motor oil, gasoline, batteries, weed and insect poisons that are dangerous to our environment. These items may be dropped off at any of the city's free ToxDrop sites. Residents are limited to disposing of twenty-gallons (20) of liquid waste or seventy-five (75) pounds of solid waste, per visit. Transport it in plastic crates, cardboard boxes, storage bins, or in other containers that are easy to see through and access. Waste brought in trash bags may not be accepted. Our closest drop off point is the Perry Township Government Center at 4925 S. Shelby Street. You may drop off items on the 2nd Saturday of each month from 9am – 2pm.

FROM THE MEMBERSHIP LIAISON

We have received several comments concerning the membership; however, if a mandatory association is not formed at the time a subdivision or a condo project is built, and is in the covenants, it is next to impossible to make a mandatory association at that point. The only way to make it mandatory is to have 100% agreement of all the homeowners to sign off on one. If we cannot encourage more people to join, we assure you that a drive to get everyone on board would never be successful. The simple truth is that if everyone would join, we could actually lower the dues a little.



YOU NEED A SECURITY SYSTEM

Please leave you outside lights on at night and lock all of your outside vehicles! In addition, there are security systems that are wired into your home as well as wireless ones. Most

You can spend as little as \$500 and the sky is the limit if you want all of the bells and whistles. There are many manufactures such as Samsung, Abode, Scout, SimpliSafe, Nest Secure, Ring, Honeywell, iSmart and Wink (this is not the end of the list). Some are easy to install so you can do it yourself and some are only available through a company and the use of professional installers.
