MESSAGE FROM THE PRESIDENT

SNOW REMOVAL

The City of Indianapolis customarily has provided snow plowing for limited areas in and around our Hill Valley Homeowners Association area. This includes the loop on Rahke Road, West Hill Valley Drive between Rahke Road and Meridian Street, East Hill Valley Drive, and East Street from East Hill Valley Drive to Stop 11 Road. As a service to owners who live within other parts of the Hill Valley Homeowners Association's area, the Association has made arrangements with a private snow removal firm to plow streets in Association areas that the city does not plow. These contractors generally plow if the snow depth exceeds 4 inches. **When snow is forecast** the contractors have told us they need you to remove your vehicles from the street and park them in your driveway, especially in courts or cul-de-sacs, because leaving your vehicles in the street side of your vehicles. Please let us know as soon as possible if there is any problem with the service we are receiving from our contractors. Contact the Scheidler's, 881-1558.

Do you ever find yourself making a trip to the landfill to get rid of heavy trash and/or debris? Save yourself 75% off the cost of going to the landfill or using a private service to haul away your items. Haul them to the <u>Marion</u> <u>County Citizens' Transfer Station: 2567 S. Belmont Ave., Indianapolis, IN 46221</u>

They are open on Saturdays from 8am to 4pm. The cost to drop-off a safely-loaded car-load is \$2.00 and the cost for a pickup truck load is \$5.00. Trailer loads are not permitted. Only regular or heavy trash items will be accepted. Items like construction materials should be reused if possible.

PROPERTY TAX APPEAL CLINIC

Monday, January 14th, 5:30pm-7:30pm, The Chase Near Eastside Legacy Center at 727 N Oriental St

Homeowners will be seen on a first-come, first-serve basis. All homes in Marion County have been reassessed for 2012. If you think the new assessed value of your home is too high, you have a limited time to challenge your 2012 property tax assessment. The Neighborhood Christian Legal Clinic is hosting a free walk-in legal clinic for Marion Country residents who own and live in homes with an assessed value below \$150,000. Volunteers from the law firm of Faegre Baker Daniels will be available to provide brief one-on-one legal assistance related to property tax questions. The Marion County Tax Assessor and representatives from the Marion County Assessor's Office will also be at the clinic to meet with homeowners.

FROM IMPD SOUTHEAST DISTRICT

Your Southeast District officers finished the year in strong fashion by engaging in a myriad of community events while maintaining our vigilance in crime fighting. Our latest preliminary crime numbers (Through 12-29-12) show that we have a 9.30% reduction in violent crime on the district and that our overall part-one crime (This includes violent and property crimes) was basically flat at a mere 0.02% increase over last year. Property crime by itself rose less than 1%. I am very proud of our officers and our engaged community members for this achievement. We will endeavor to maintain and even improve on our successes in 2013.

Speaking of engaged community members, I want to publically thank Ms. Carolyn Key, MA for her involvement again this year in our annual Shop with a Cop program. This is just the latest contribution Carolyn has made to our district as she participates in many of our events throughout the year and remains one of our most active community members. This does not mean that I don't appreciate the many contributions of the rest of you, but I think from time to time it is nice to point out the exceptional commitment and contributions of specific individuals. 2013 INDY PARKS AND RECREATION ICE RINK AND SMOCK DOG PARK

<u>Perry Park Ice Rink</u> opened on October 1st. It is located at 451 E. Stop 11 Rd. and you can contact them directly at 317-865-1833. They are open most days for at least a 2 hour window of open skating.

<u>Annual Pooch Passes</u> are based on the January-December calendar year. Passes include a tag for your dog and a gate access device for you for <u>one</u> of the four Indy Parks Bark Parks.

<u>Very Important Pooch Pass</u> is based on the January-December calendar year. Passes include a tag for your dog and a gate access device for you for <u>all four</u> Indy Parks Bark Parks. VIP passes are available for purchase at the Broad Ripple Park Family Center. Annual pooch passes are available for \$75 (VIP passes for \$125) or daily passes are available for \$5. A discount will be applied on tags for your second and third dogs!

To obtain a Pooch Pass or VIP pass:

1. Bring with you, all pooch vaccination records documenting current inoculations for Rabies, Parvo, Distemper and Bordatella. 2. Visit the Perry Park office to obtain a Pooch Pass.
