MESSAGE FROM THE PRESIDENT

Dear Hill Valley Residents:

The topic of our membership was discussed at our last board meeting on November 19, 2018. Resident membership has consistently dropped the past few years. In 2013, we were at 53% membership, currently we are at 44%. This is the lowest ever in the history of Hill Valley Homeowners Association. It is very disappointing for myself and the other board members.

One board member suggested we may have to dissolve due to lack of participation. The suggestion was if it lowers to 40%, we would have no choice but to cease to exist. That thought shocked me. If that happened, who would take care of serious issues that arise?

For example: On September 16, 2018 a vehicle crashed into the East Hill Valley island. The sign was destroyed along with damage to the landscaping. Dave Ritchie and myself started the process. First, we had to get a police report, take pictures of the damage, then contact the driver for his insurance information, contact his insurance carrier, much time filling out forms, getting bids from contractors, sending more pictures, and going back and forth with the insurance contact. In the end, we were fortunate that the driver had insurance which paid the claim. By the way, the driver was not hurt, only a few bumps and scratches. If the driver didn't have insurance, the association would have had to pay. The total cost was \$4,452.03. If there was no association, how would these repairs have been made with no one in charge of problems or incidents? In less than six weeks, replacement and repairs were complete. This is just one most recent responsibility we accomplished.

We have no intention of dissolving our association. Since the subject was brought up, I thought it should be addressed. We need your support. Please consider paying your membership dues. Our goal is to keep Hill Valley a well maintained and safe community. As a reminder, board members are all volunteers. I pay my \$45.00 per year dues as do the other board members. To those of you who have been long standing members, thank you. Your loyalty and support for your community is truly appreciated.

MESSAGE FROM THE BOARD

Happy New Year 2019! We hope you all had a delightful Holiday and a Happy New Year. It's again that time of year to keep your cars and other vehicles off the street when there is snow forecast so the snow plows can get through. Also, keep your storm drains cleaned and open. Leaves and debris keep the snow melt from draining and cause ice patches on the streets. Thank you to all of you for your continued support this past year. It is now time to renew your support-our envelope is enclosed.

SNOW REMOVAL IN THE NEIGHBORHOOD

Did you know that your Hill Valley Homeowners Association is responsible for plowing snow from most of the streets in our neighborhood? No tax dollars are spent and the city is not responsible for plowing our neighborhood streets. The City of Indianapolis customarily has provided snow plowing for limited areas in and around our Hill Valley Homeowners Association area. This includes the loop on Rahke Road, West Hill Valley Drive between Rahke Road and Meridian Street, East Hill Valley Drive, and East Street from East Hill Valley Drive to Stop 11 Road.

As a service to owners who live within other parts of the Hill Valley
Homeowners Association's area, the Association has made arrangements with a private snow removal firm for them to plow streets in Association areas that the City does not plow. We hire private companies to plow our streets. These contractors generally plow *if the snow depth exceeds 3*".

When snow is forecasted, the contractors have told us they need you to remove your vehicles from the street and park them in your driveway, especially in courts or cul-de-sacs. Leaving your vehicles in the street only complicates, and can even prevent plowing. This can also invite having plowed snow packed up against the street side of your vehicles. CHRISTMAS TREE DISPOSAL

If you have a live tree this year and want to recycle it, the Indianapolis Department of Public Works (DPW) and Indy Parks are accepting live Christmas trees at multiple drop-off points throughout the city for recycling. Now through Thursday, January 31, 2019, residents can drop off live trees at nine different locations.

Trees must be free of ornaments, tinsel, tree stands, and all other decorative materials. Trees can be dropped off at designated drop-off points in the park from dawn to dusk. Drop off locations are as follows:

any abnormal behavior occurs. If you are interested in learning how to compile or organize such a phone tree, please call one of our HVHA board members and we will gather the information from one of the groups in our neighborhood.

BARKING DOG(S)



Do you have a dog that is barking the first thing of a morning or the last thing at night? A barking dog is a problem for your neighbors who are attempting to sleep or even watch television and it is in violation of the city ordanance.

Howling, yelping, barking prohibited <u>This site gives you the city ordinance</u> that covers animals frequent or habitual howling, yelping, barking, screeching, other vocalization or otherwise shall cause serious annoyance or disturbance to persons in the vicinity. Go to the <u>Mayor's Action Center</u> to file a complaint.

A person who violates any provision of the ordanance can be punished as provided in <u>Section 103-3</u> of the ordanance. A fine is not be less than \$25.00. Continued violations may also subject the owner to impoundment of the animal.

WHAT IS ON THE TOP OF THE MONUMENT?



Liberty, Victory or simply "crowning figure" is standing atop the monument in the center of Monument Circle. The current administration has done a great job of taking the likeness, added a bit of color, put the date that the City of Indianapolis was established and added Indianapolis to make the image portion of the letterheads. Under INDIANAPOLIS will be the name of the office (Mayor Joe Hogsett, Department of Public Works, Business & Neighborhood Services, etc.).

She is facing south with a sword in hand in case the South were to rise again (that is said with tounge in cheek because I really do not not know). The <u>history of the victory sculpture</u> is found here.

Recognized as one of the world's outstanding monuments, the structure has come to symbolize both the City of Indianapolis and the state of Indiana. The <u>Soldiers & Sailors Monument</u> is Indiana's official memorial to the Hoosiers that served in the Revolutionary War, the War of 1812, the Mexican War, the Civil War, the Frontier Wars and the Spanish-American War. Did you know that the monument is only fifteen feet shorter than the Statue of Liberty?
