HVHA BOARD AT WORK

The HVHA board felt that many of you may not be aware of the work that is being done by the board. We have added this segment to the Newsletter to keep you informed.

<u>July 2014 Meeting</u>: There was a neighborhood concern brought to the board about golf carts being driven by unlicensed drivers and the danger that is created by them on the streets. We ask that you please refrain from the use of golf carts in the neighborhood. It is illegal and very dangerous. The remainder of the meeting was spent finalizing the picnic plans. For those in attendance at the annual event, we hope you had a great evening.

<u>August 2014 Meeting</u>: We did a recap of the annual picnic, and made some notes on planning for next year's picnic. Steve Sullivan accepted a position as a board member, and we welcomed his involvement in the betterment of our neighborhood association. Planning for the meeting of members and neighbors in October was also discussed.

<u>September 2014 Meeting</u>: Ryan Clem, from the Mayor's office, was present to discuss the issue of solicitors in the neighborhood. As most of you are aware, there are some signs stating we are a "no solicitation" neighborhood. Several questions came to the board regarding this issue. There has been some discussion about this, and the city will let us know what we need to do if we do not want someone on our doorstep uninvited. More info is to come later.

<u>CRIME WATCH CORNER:</u> Home Security...Opening your door to strangers:

- Take Care...you don't ever have to open the door.
- Peepholes...to see who is there. Peepholes are recommended because the person outside doesn't know that you see him/her. Peepholes should be wide angle. If peephole is covered, do NOT open the door.
- Chain locks are not the best security due to being mounted with short screws and some have weak chains.
- Door wedges really work. A door wedge is a better alternative when you wish to open your door only a few inches to speak to a stranger. This device can be found in most hardware stores.

With Halloween just around the corner, we would like to remind parents and children to stay within the neighborhood and go only to homes you know. Make sure your child's costume is not too long to avoid tripping; make sure they can see well through masks or use make-up instead. Wear light colors and add reflective tape. **BE SAFE, NOT SORRY!**

LOCAL HOMESTEAD CREDIT VS. STATE HOMESTEAD DEDUCTION

The mayor has proposed dropping the local homestead credit but it does not affect the state homestead deduction. The local homestead credit was in response to the property taxes before the 1% tax caps. Since the 1% cap, it is no longer needed to stabilize property tax bills (more than 80 counties have already dropped the local homestead credit). There is no effect if you are already at the 1% property tax cap. If you are below the 1% cap, the average impact will be \$1.84/month. This will not affect the \$45,000 state homestead deduction. The state deduction lowers your home's value by 60% or \$45,000, whichever is less, for property tax purposes.

UPCOMING ANNUAL BOARD MEETING

POLL WORKERS NEEDED

Want to help democracy and earn some extra money? Be a poll worker for the November 4, 2014 general election! To serve, you must be a registered voter, live in Marion County and attend training. You can sign up through this <u>website</u> or call their office at (317) 327-VOTE for more information. Eligible 16, 17, and 18 year-olds are also encouraged to check out the <u>Student Poll Worker Program</u>. Interested students must have at least a 3.0 GPA, permission from their school and parent or guardian, and attend training.

ABSENTEE BALLOT FORMS AVAILABLE

Absentee ballot application forms are available at <u>indy.gov/ELECTION</u>. If you plan to vote by absentee by <u>mail</u> or <u>traveling board</u>, please make sure you use the correct absentee application. If you choose to vote early, you will complete an application on-site. Be sure to read the instructions and complete the application fully. Many people also think applications are kept on file from election to election. They are not! You must apply for an absentee ballot in each election. Applications to vote by mail must be received by Monday, October 27; all absentee mail ballots are due by noon, Tuesday, November 4. We strongly encourage you to submit your ballot before Election Day!
