FALL LEAF PICK-UP

Beginning about the second Monday in November through about the first Friday in December (the city has not announced



their schedule yet, but we will announce it on an e-mail update when it is announced), up to 40 bags of leaves can be picked up each week free of charge. When setting out items for pick-up, residents should ensure that trash is separated from leaves. All leaves must be bagged and placed at least three feet away from the trash collection cart, off of sidewalks and public rights-of-way, in order to allow trucks to collect your trash. Place leaves in large plastic trash bags, and place the bags on the street by 7 a.m. on your collection day. Residents should refrain from

using paper bags as they deteriorate and fall apart in wet weather.

Leaf season is a great time to clear your nearby storm drain inlets and keep them maintained to prevent drainage and flooding problems. *Burning LEAVES as well as TRASH*, *is illegal* in Marion County as it releases harmful particles into our air. Illegal burning may result in fines up to \$2,500. Never rake leaves into the street. SNOW!

Did you know that your Hill Valley Homeowners Association is responsible for plowing snow from most of the streets in our neighborhood? No tax dollars are spent, and the city is not responsible for plowing our neighborhood streets. The city streets are plowed by the city. These include Rahke Road to West Hill Valley Drive and East Hill Valley Drive/East Street to Stop 11



Road. We hire private companies to plow all other streets in our neighborhood. We have not had snow heavy enough to plow for the last few years and we have been able to build our reserve. It takes two inches of depth in several locations before we call our snow removal contractor.

If there is a snow forecast, please park your vehicles in your driveway. Parking in the driveway speeds up the plowing so our streets are open faster, and it keeps you from getting your vehicle plowed in on the side of the street.

Courts are always a problem because the streets must be plowed first. Then the trucks must find a place to stash the court snow without

blocking the street or the driveways. As usual, the board is always considering not plowing those courts where there are no members. Those who pay the modest dues are always disgruntled with others who get a free ride. Please consider joining the association to avoid this problem!

SUB ZERO WEATHER REMINDER

As a reminder, the City of Indianapolis has passed a law for all Marion County residents regarding their **pets**. It states that all pets need to be inside their owners home when the temperature reaches 20 degrees or below. There have been several cases of pets who have frozen to death outside. Please keep your pets inside during the extreme cold weather.

NEIGHBORS LOOKING OUT FOR NEIGHBORS

We cannot emphasize this too much. We truly all need to be aware and vigilant in regards to our surroundings in the neighborhood. Unfortunately, we are living in a world of violence and destruction. There have been quite a few break-ins, vandalism both car and home, mailbox blown up, etc. Please look out for your neighbor and call the police immediately if you suspect any foul play. Many of our residents have formed small phone trees within their street(s) and communicate to one another when any type of abnormal behavior arises.
