The HVHA annual fee (\$45) was actually scheduled to be paid by March 31, but it can still be paid, there is no late fee at all! Please let us understand that our desire to make our neighborhood a nice and safe place should always be accompanied by the annual fee.

LAWNS AND LANDSCAPING

Spring is upon us please keep your lawns and landscaping maintained. Most folks in our neighborhood work really hard to maintain their yards. We ask all homeowners to keep the dandelions down and not let the seeds spread to other yards. If you are one of the homeowners with a good growth, please mow often. As long as you catch the yellow blossoms before they mature into white seeds, you will be able to stop the weed from spreading. Set the lawn mower to prevent it from cutting the grass lower than 2 to 2 ½ inches, since longer grass will block out the sunlight needed for dandelions to grow. Merely mowing down the dandelion will not permanently kill the dandelion, but it will keep it from spreading to your neighbor's yard.



SPEEDING IN WEST HILL VALLEY



We are still receiving a number of complaints from Hill Valley residents in regards to the speeding up and down West Hill Valley Drive. IMPD and the Mayor's Liaison still continue to work on this issue. Since the election, we have been waiting to hear if we will keep our current Mayor's Liaison, Kelly Foulk. We will keep you informed as soon as we know for sure what is going to happen. Kelly has worked very hard to help our board and our neighborhood with many issues. The city will be conducting various tests of our neighborhood in order to get information needed to get three way stop signs installed. The police have been notified NUMEROUS times

regarding the parking issues we seem to continue to experience along West Hill Valley Drive, especially at the stop signs at

Rahke Road and West Hill Valley Drive. There is **NO PARKING** at any time on West Hill Valley Drive. By parking on the street, you are causing traffic jams for the school buses and emergency vehicles. There have been many "CLOSE CALLS" of pedestrians and residents riding bikes, nearly being struck due to this ongoing problem we seem to be having. Please **DON'T** park along this street, especially at the stop signs.

ANNUAL MEMBERSHIP DUES RENEWAL



Of course you can always pay your dues at the gate.

Oh, and add in the fact that this includes SNOW removal which can break the piggy bank rather quickly. PLANS ARE UNDERWAY TO CHANGE THE METHOD OF TRASH PICK-UP IN MARION COUNTY.

Prior to the mid-70s, many people had a 55 gallon drum in the backyard where they burned a lot of trash and leaves. In the early 70's, more information was available on the need to recycle and to stop open air burning. To accomplish this widespread trash pick-up became available to all of Marion County. Residents were encouraged to recycle and small containers were made available or could be purchased to sort trash for pick-up. Containers were different colors to help determine the type of trash that went into each container (i.e. glass or metal, etc.). This method was never very successful because it was very labor intensive for apartment residents and home owners. The need to have multi-colored sorting bins in one's house or apartment created a host of problems. Public trash receptacles were labeled but often ended up containing a wide variety of trash items.

To seek information on possible solutions for these issues, a member of the Indianapolis City-Council went to the state of Washington to observe a mass-burn operation that was state of the art and being acclaimed as the wave of the future. Washington State was considered a leader in the "green" movement and had tested and pioneered many new ideas for dealing with urban trash removal.



That person returned and held county-wide meetings to explain how the Washington State system worked. It was a controlled mass-burn operation that produced clean ash and steam. The steam could be off loaded and used to heat commercial buildings as well as used for manufacturing. The ash could be used as land fill and was clean enough to build on in future years. At this time, Marion County collected enough trash every 3 days to fill the Indianapolis City County Building from basement to roof (30 stories). The trash that was collected (30 stories of it) was being dumped into landfill sites.

Along with the support of the Mayor of Indianapolis, the City-County Council voted to develop a mass burn operation for Marion County. Once that was in operation, Marion County residents were able to combine trash into a single stream for automated processing by Covanta. That trash is dumped at the Covanta Indianapolis Inc. on Harding St. just south of Raymond St. to be processed.

Mayor Hogsett has cancelled the contract for that service and is seeking input for the development of a new system of trash pick-up and disposal. Very little detail is available at this time, but one suggestion is that residents might have to keep different color clear trash bags and sort all the trash prior to pick-up. Any trash bag determine

to have the wrong items would not be picked up. This method will require all home or business trash to be presorted.

We do not know what the solution to this is or what will be proposed by the mayor, but do think that we all should seek answers and stay informed. Our city-county councilor is a place to start as well as the trustee. The more we ask questions and seek to have a say in this very important decision, the more we will have a solution that serves the greater good of the community. Your Hill Valley Homeowners Association will pass along more information as it is available.

Recently I was notified by the HVHA board concerning the plans of PMHS (Perry Meridian High School) football field and stadium renovation/expansion. For those who are not aware, PMHS plans to install an artificial turf to the existing field along with new bleachers, a concession stand, and restroom structure. In doing this, several mature trees will be removed and the offset tennis court will be moved directly behind some homes' fence line. As the precise plans of PMHS keep changing, our board has been trying to minimize the negative effect to our neighborhood. Issues like this, along with snow removal are the types of things that are dealt with behind the scenes. I have started attending the monthly meetings and plan on becoming a board member. We have a great neighborhood and homeowners' association. You can help keep it that way by paying your \$45.00 yearly dues.

PERRY HIGH SCHOOL FOOTBALL STADIUM

Perry Meridian High School will be getting a rebuilt football stadium and bleachers. The project has been in the works for some time, and many issues have come up. Your HVHA is working with Dr. Little to help facilitate the new construction while protecting the privacy of our neighborhood.
