PARADE OF SHAME

There has been a lot of discussion by the board and neighborhood about the U-Tube video, "<u>Parade of Shame</u>." Many of us on the board are lifetime residents of Hill Valley, and we are ashamed of all the drivers breaking the law. You are putting

yourself and others in danger by your actions. The ticket for running a stop sign will cost you \$300. Why is this stop sign or any neighborhood stop sign, different than the one at the corner of your street where YOUR children cross? Please stop at a stop sign; it is there for a reason. Save a life; it could be YOURS! The board has had a discussion about placing more police presence in order to deter this shameful/dangerous behavior.



PARKING ISSUES



There are restrictions on <u>parking commercial vehicles/trailers</u> that are not engaged in actual delivery of services. Commercial vehicles are only permitted to be parked or stored in a location zoned specifically for that purpose. Commercial Vehicles, besides semi-trucks, there are several types of vehicles that are considered commercial (i.e. tow trucks, box trucks, flat trucks, construction equipment vehicles, and many others). Similarly, inoperable vehicles must also be kept completely inside an accessory structure. Any violations of these rules can be reported to the

Mayor's Action Center at (317) 327-4622, by anyone and a case number will be assigned for follow-up.

Cover Crop Seed Details

Oat and cereal rye packets are made to plant 100 square feet.

Limit 5 per gardener.

Crimson clover and hairy vetch packets are made to plant 400 square feet.

Limit 1 per gardener.

INOPERABLE & ABANDONED VEHICLES

There are restrictions on parking <u>inoperable</u> (vehicles that do not start or have been sitting) <u>or abandoned vehicles</u> on public or private property. Any vehicle found as inoperable or abandoned can be towed if that vehicle does not have a valid license plate, if it has one or more flat tire(s), if a front windshield is required and is missing or heavily damaged, or is otherwise unable to be driven on a public street due to mechanical problems. Inoperable vehicles must also be kept completely inside an accessory structure. Any



violations of these rules can be reported to the <u>Mayor's Action Center</u> at (317) 327-4622, by anyone and a case number will be assigned for follow-up.

BEING A GOOD NEIGHBOR

Planning something for your yard? Will it affect the neighborhood? Will it be too close to the neighbor's swing set, fence, dog, yard, etc.? How will it look when it is finished? Do you have a play set in the front yard (or side yard if you live on a corner lot) that presents an eyesore? How about a garden or an old vehicle that is not used much? In short, how does your property look? Think about how it would look to you if you were coming into the neighborhood for the first time with the intention of purchasing a home. Please use some common sense when taking care of your property; perhaps it will encourage your neighbor to do the same.

OPOSSUMS IN HILL VALLEY

Opossums look like they could be nice cuddly pets but they are wild animals that can and will defend their young. The best thing to do is to leave them alone and make sure there is no food supply, including trash, left out that they can get into.





FROM THE MAYOR

The Mayor's Action Center (MAC) provides the citizens of the Consolidated City of Indianapolis and Marion County with a single point of contact to request City services, obtain information, or provide feedback. The following are just a few of the issues that can be reported through the MAC:

- Potholes
- Missed trash collections
- Abandoned vehicles
- Traffic signals or signs
- Zoning violations
- Animal control, and many more!

Many MAC services can be requested around the clock through <u>RequestIndy online</u> and the free RequestIndy mobile applications. In addition, you can also check the status of your requests on these tools.
